Dear Representative,

The National LGBTQ Anti-Poverty Action Network ("The Network") **urges your boss to support quick passage of the Build Back Better Act (BBBA) in the House of Representatives this week.** The Network is a member-based coalition of over 100 national, state, and local organizations working in the LGBTQI+, anti-poverty, and anti-hunger movements to increase awareness about and action on LGBTQI+ poverty. LGBTQI+ people disproportionately experienced poverty before March 2022, and the pandemic has exacerbated this. Low-income LGBTQI+ people and families cannot wait any longer for the BBBA to pass. The time is now.

BBBA would be transformational for addressing poverty among LGBTQI+ people and their families through:

- **Universal preschool** for all 3 and 4 year olds;
- **Extending the improvements to refundable tax credits.** BBBA would extend the expanded Child Tax Credit (CTC) monthly payments to families for another year and make the CTC permanently refundable, helping millions of low-income people who have been locked out of the full benefit for so many years. BBBA would also extend the Earned Income Tax Credit to around 17 million low-wage workers, including many low-wage LGBTQI+ workers.
- **Affordable high-quality child care,** ensuring that families pay no more than 7 percent of their income on child care, expanding care to about 20 million children per year, and improving the wages of child care workers who are currently underpaid;
- **Paid family and medical leave** that includes critical, inclusive family definitions so LGBTQI+ people are not excluded from caring for loved ones;
- **More affordable in-home care for older adults and people with disabilities,** while supporting workers providing this care;
- **Making housing more affordable for families and individuals** by investing in long-term rental assistance for hundreds of thousands of families and repairing public housing. BBBA will also build and maintain housing affordable to extremely low-income renters, which is where the largest supply gap is. Further, BBBA will provide down payment assistance for first-time, first generation home buyers

- **Investments in immigration reform** to reduce backlogs, expand legal representation, and make the asylum system and border processing more efficient and humane - critical supports for LGBTQI+ people seeking asylum;
- **Investments in workforce development and equity in college education** by raising the maximum Pell Grant and providing supports to Historically Black Colleges & Universities, Hispanic, tribal colleges and universities, and other institutions serving students of color;
- **Expanding health care coverage to millions**, by extending Medicaid to 4 million low income families and individuals, and expanding Medicare to cover hearing benefits;
- **Support nutrition assistance for children** by expanding access to nutrition programs during the school year and the summer;
- **Creating jobs and advancing environmental justice** through investments in clean energy and sustainability which prioritize disadvantaged communities; and
- **Fully paying for these investments in our communities** by ensuring that the ultra-wealthy and large corporations pay more of their fair share of taxes.

The majority of people in the United States support these policies, which will provide a strong foundation for the country to have an equitable recovery from the COVID-19 pandemic and ensure we do not return to the pre-pandemic status quo of inequities for LGBTQI+ people, people of color, and women. We urge you to support swift passage of the BBBA this week.
